

What is Planning?


The development and design of land use and the built environment, concerned with the planning of settlements and communities, typically analyzing land use compatibility as well as economic, environmental and social trends

Urban Planners investigate research and analysis, strategic planning, architecture, urban design, public consultation, policy recommendations, implementation and management



Our goal: To increase the visibility of the Redline Extension.


Our Plan: To meet with you, the students, and engage/inspire you to push for the development of the RLE






Currently, gentrification (or a plan to prevent gentrification) is not included in the CTA's Draft Environmental Impact Statement (EIS)

RLE Issue: Jobs & Workforce Development (part II)

- Good living wage jobs can be a method of preventing gentrification
- One way to prevent gentrification & ensure that good jobs go to residents is through a Community Benefits Agreement (CBA):
 - a legal agreement between the project developer and a community coalition on the benefits that a development project will offer.

RLE Issue: Environmental Justice

Environmental Justice and RLE

- Environmental Justice is a priority now for many planning organizations even the Federal Department of Transportation. It is defined as making sure the adverse/negative effects of government activities don't fall on minorities and underserved populations
- In terms of sustainability, the RLE is a way to shift away from automobile usage
- The South Side experiences the disparate impact of many infrastructure policies in terms of their negative environmental impact –freight train traffic, the Dan Ryan Expressway, etc
- The RLE has the potential to disrupt many communities if not handled properly by the CTA – ensuring that it is as sustainable of a means of transit as can be

Health Justice and RLE

- Health desserts, pharmacy deserts, and food deserts are three of many parts of the umbrella idea of opportunity deserts that exist on the south side of Chicago
- Lack of access to adequate health care can be seen in how hard it was to get the trauma center in Hyde Park the past few years
- Pharmacies often get TIF funding to open in certain districts and it isn't coincidental that they are closing in south and west side neighborhoods, it is part of the bigger problem of disinvestment
- For people in Altgeld garden, the TCA clinic is the closest health center and the nearest hospital would be Advocate
- The bigger issue is that trauma centers are few and far between, but also hospitals provide access to opportunity as well so everything is tied together

The RLE now, and the progress on these issues

- So for now, it is important to demand that your alderman are aware that this is an issue you care about because it's gotten to the stage where it is all a money game
- The CTA has multiple phases it initiates to begin construction. We are still more than two years away from construction even starting but what does that mean?
 - They have to secure funds to do research on the engineering process, they
 have to make sure it's a priority when it comes to the city budget, and they
 have to try and obtain as much money they can from the federal, state, and
 city government to do so
 - As of right now it was not included in governor Pritzker's budget or Lori Lightfoot's

RLE Issue: What is Tax Increment Financing (TIF) funding??

- TIF funding is a major part of this game
 - It is basically money allocated by the city to certain districts in order to promote development
 - The state is now starting to recognize transit as one way to get at development and the city is beginning to roll out transit TIF funding
 - As with any kind of city funding, securing TIF funding depends on your alderman, so if you're passionate about the RLE and making sure it happens, tell your aldermen!

Maps are known to be an effective storytelling method. Imagine a tool in which combines powerful narratives, text, and imagery; this is a map.



COMMUNITY MAPPING


Unlike your typical regional map that you'll discover on your county's website, a community map is produced collaboratively by residents!


The deliverables that should form this map are *residents' knowledge and resources*.

Community maps are a *powerful tool* because they can initiate *radical social change!* <u>Transparency</u>, <u>inclusion</u>, and <u>empowerment</u> are all enacted in the formation of community mapping.

Civic Engagement: People for Community Recovery

- Founded in June 1979 by Hazel M. Johnson to fight for repairs in Altgeld Gardens
- Focus became urban environmental pollution after study showed Southeast side had the highest incidence of cancer in Chicago
- Altgeld Garden's Youth Environmental Justice Photovoice Club
- Also in Altgeld Gardens: Carver Military Academy, TCA Clinic

Civic Engagement: CTA (Chicago Transit Authority)



- Public development agency for the Red Line Extension

Civic Engagement: Elevated Chicago

- Mission: "We are working to improve the built environment (the physical structures and spaces available to people) for greater climate resiliency, to increase exposure to arts and culture, and to improve public health outcomes for residents, without residential displacement, for people of color in ways that acknowledges racial inequities that have long existed in opposition to this work."
- No information on the Red Line Extension on their website currently
- Their next event is December 18th at 4pm at the Chicago Cultural Center. It is titled "Undesign the Redline Youth Summit meet-up"

City Bureau: Open Reports Report card

- CityBureau is a journalism group on the south side that recently published a report card on city agency transparency, overall the city did poorly but specifically with <u>transportation they got a C</u>
- You can get involved with them through the documenters program which is a PAID opportunity to report on city hearings
- You can also go to different public newsrooms they host in Woodlawn every Thursday on a variety of different civic engagement topics
- The MIVKA challenge is specifically geared towards amplifying student voices through different organizing programs in the city, if you are interested you can google Mivka challenge Chicago
